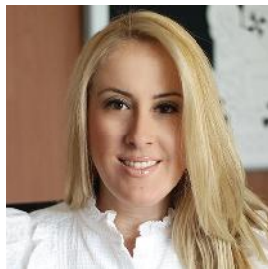

■ WHY USE A TRUST?

Although originally intended to simply regulate the succession of family wealth, the concept of trusts evolved into a versatile, multi-purpose and highly efficient vehicle.

Today, trusts are used to address a very wide range of international financial and legal concerns as well as for international tax planning.

Trusts could vary in form to satisfy the needs and objectives of those looking to establish a trust. Although trusts can be generally similar, the structure, contents and operation of each trust can differ greatly.

■ WHY A CYPRUS INTERNATIONAL TRUST?

- Cyprus law is based on English common law and is fully compliant with EU legislation
- Cyprus trust law is supplemented by the English doctrine of equity and English case law
- The great value of a common law system which can be adapted to situations that were not contemplated by the legislature
- Tremendous flexibility in adopting a foreign law
- Short limitation period (of two years) for challenging a trust with the burden of proof lying on a potential creditor
- Comparatively low cost of establishment and administration
- Favourable tax treatment
- No limitation regarding the duration of the continuation of the validity and enforceability of a trust
